

SB 1990 – CALL SENATE LICENSING COMMITTEE MEMBERS ASAP

It is urgent that our stakeholders and CCNBNA membership call the 9-senate licensing committee member in Springfield. We have an opportunity to pass SB 1990 and correct neglectful language in the nurse practice Act.

The Chicago Chapter National Black Nurses Association is requesting that all nurses in Illinois work together to pass SB 1990. The CCNBNA has valued legislation that could improve the Practice of Nurses and provide safety for the Public. This is an opportunity for the Chicago Chapter NBNA to make a difference in removing neglectful language from the Nurse Practice Act and not allow non nurses to administer medication.
